PRIVACY POLICY

1. PRIVACY POLICY

The following document governs and details the data safety practices of RV Cooling Unit Warehouse LLC which is an interactive online platform for shopping for Cooling Units and Parts. On and through the RV Cooling Unit LLC platform the privacy of all of our buyers, customers and users is protected and respected. This privacy statement is drafted in order to declare our website's data protection and data collection practices by explaining specifically how we protect users' data, and what measures have been taken in order to be in compliance with different local and global privacy laws. This policy is written for all the users, customers, buyers and members and (herein collectively will be called "users") to understand how we (also referred to as "we", "our", "RV Cooling Unit Warehouse", "RVCOOLINGUNIT2.COM" and "platform") uses, collects, shares, and protects users' information and data. We request our users read this privacy policy statement before using our services. The users of our platform's services will be assumed to be in agreement with our privacy statement after we have published this Privacy Policy on/through our platform.

2. COLLECTION OF DATA

Our website collects information that is necessary for the purpose of delivering our products and services. Personal information includes (but is not limited to) the full name and e-mail, age along with other data (processed automatically) of the user. The information which will be collected in this process will be used to provide services to the user as well as in order to communicate with that user through e-mail and/or newsletters. Some information on our website will be gathered automatically through different tools and plugins.

2.1. Users' Information Collection.

There will be a collection of information from all of our users when they create an account on our website if they will use any of our given services. The information that will be provided to us includes but is not limited to:

- 1. Name
- 2. Email address
- 3. A Contact Phone Number
- 4. Address for Billing and Shipping
- 5. Area or Zip code
- 6. Users' Third-Party Related Information
- 7. Payment Related Information (Processed Automatically Through Third Party Platforms)

8. Any additional information relating to the users that they provide us directly through RV Cooling Unit Warehouse LLC website or indirectly through our platform or online presence such as 'cookies'.

2.2. Automatic Information Collection

We also collect information that is collected by general websites and relative tools/plugins for the purpose of rendering normal services. This type of information includes (but is not limited to) the usage of our services by users, referring nodes, device OS and its type, language and its preference, and the date and time of users' browsing history. We may release such information in aggregate form for the purpose of making our services better. Please note that in aggregate form none of the individual users can be identified. Our website may also collect information that is considered personal identifiable information such as IP addresses and other information collected through cookies. We may share this information with third parties in order to be compliant legally.

3. USE OF COOKIES (COOKIE POLICY)

Our platform uses, collects, and stores cookies on users' devices. This cookie policy is written according to the privacy rights and user rights policies and we are letting our customers know that their data may be collected and they can contact us if they want to have their data removed. A cookie is a log file that collects certain information and is stored on the user's or visitor's device or personal computer. This information will be provided back to the device if such a user or visitor makes a return visit. The most common types of cookies are session cookies and permanent cookies. Session cookies are temporary cookies that are deleted once the user exits the browser while permanent cookies remain in the user's or visitor's browser until the cookie log files are either deleted by the user or expired on their own. Mainly we use cookies in order to (i) understand how visitors are arriving at this platform; (ii) in order to monitor the usage of our platform's visitors and traffic; (iii) remember when a user last visited our website and if the cookie persists continuing that user's usage from the last time; (iv) in order to keep track for analysis we may store analytical cookies; (v) track for the purpose of marketing; (vi) for error reporting; (vii) for customer services; (viii) to conduct research and development by gathering user data in aggregated form. A functional cookie is a type of permanent cookie that is necessary for the purpose of some services. Please note that the cookie does not contain any personal identifying information. Users can also change their browser settings to ensure that the collection of cookies is disabled. However, doing so will make many of our services ineffectual.

5. SECURITY OF USER DATA

We have also implemented encryption methods and the use of pseudonymization as well as SSL certification to protect users' data.

5.1. Users' Data Protection Rights

All users are entitled to have access to their personal information and to be informed about the data collection process.

Users have the right to:

- 2. have your personal data updated, rectified, erased or blocked;
- 3. receive information about you that you have provided to us;

- 5. have your personal information transmitted to another data controller (data portability). In order for you to exercise your data protection rights we are obliged to verify your identity.

Please note that only users of our website have data protection rights because we can only verify individual users if they are logged in

5.2. Updating And Amendment Of Information

5.3. Withdrawal Of Consent

All users at any time, withdraw any consent you have given to us, and we will no longer process your personal information unless we can continue the processing based on another purpose. If you wish to withdraw your consent, you can withdraw it in the

6. DATA RETENTION

We keep records of your communications with us for six years in case we have to refer to a conversation or inquiry. This could be because it relates to our legitimate business interests, you are still in communication with us, or for legal reasons.

If you haven't opened one of our emails for some time, we may contact you to ask if you still want to hear from us. - 4. Address fraud, security, or technical issues
- 5. Protect our rights or property or the rights or property of those who use our services

8. PRIVACY AND GDPR USER RIGHTS

In compliance with the users' privacy rights, this statement has been provided for all the users of our website who are using any or all our services. All users have the right to access their personal information and they have the right to know how their data is being stored on our platform. Users can also have their data removed or transferred from our platform.
